4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Water spray, foam, dry chemical, and CO₂. Do not use a heavy water stream as it may spread the fire.

HAZARDOUS COMBUSTION PRODUCTS: Carbon oxides, metal oxides, ammonia, and nitrous gases may be released. If heated to the point of fume generation, zinc fumes may cause metal fume fever. Otherwise, zinc is non-toxic.

SPECIAL FIRE FIGHTING PROCEDURES: Self-contained positive-pressure breathing apparatus and protective clothing should be worn in fighting fires involving chemicals. Cool fire-exposed containers with water or fog. Attack from upwind.

UNUSUAL FIRE AND EXPLOSION HAZARDS: Not considered flammable, but may burn at high temperatures. Product is not explosive. Hazardous reactions will not occur under normal conditions.

6. ACCIDENTAL RELEASE MEASURES

CONTAINMENT: Contain any spills with dikes or absorbents to prevent migration and entry into sewers, streams, or public waters. Avoid release to the environment.

7. HANDLING AND STORAGE
